HANDICAP: 80% of 230.

AVERAGE: Highest 2018-19 Ending Book Average as Reported to Bowl.com
If no 18-19 book average, 18-19 league ending standing sheet will be used.
If no average per above, Highest 2017-18 ending book average will be used.
If none of the above apply, bowler will bowl scratch (230).
Any misrepresentation of average will be cause for disqualification.

RERATING: Rerating requirements of USBC rule 319E shall apply to all entrants. Those who are affected by this rule are to report rerating under these terms prior to bowling or be disqualified. Those affected by this rule are to present a January 1, 2019 Standing Sheet.
